- Ensure continued performance improvement based on quality assurance oversight activities, quality control processes, and customer feedback.
- Answer IOSA questions from PSP Operators.
- Responsible for direct communication with Operator point(s) of contact(s) for each assigned discipline.
- Review relevant Operator documentation, implementation, and past IOSA audit reports for Continuous Conformance Monitoring (CCM) within the PROS Support Program.
- Complete work assignments as directed by Lead PSA, following the processes/procedures of the PROS Support Program Manual (PSPM).
- Assist with CAR Closure during CCM Follow-Up and IOSA CAR Closure as assigned by Lead PSA.
- Be available during assigned Operators IOSA audit for Live IOSA Support.
- Attend and participate in the Annual PSA Standardization Meeting and Recurrent PSP Training.
- Maintain PSP currency.

- Documented and verifiable evidence of conducting a minimum of four (4) aviation industry audits within the scope of IOSA.

Experience Prerequisites:

- Holder of an ATPL with at least five (5) years' experience as a pilot on transport category aircraft with MTOW above 5700 kg.
- Or, holder of a Flight Engineer license/rating with five (5) years' experience as a flight engineer on a transport category aircraft with MTOW above 5700 kg.
- At least two (2) years of experience in a flight operations management position or equivalent.
